6M2012 vs. 6M2011

Revenue

The Group's revenue decreased by RMB 89.7 million (or 26%) to RMB 256.2 million. The decrease in revenue was due mainly to the decrease in the sales of the Zipper Chain (RMB 54.5 million), Zipper Slider (RMB 37.1 million) (collectively referred as the "Zippers segment") and the Trading segment (RMB 17.2 million). This was partially offset by the increase in revenue contributions from newly acquired processing operations namely Fulong Zipper and Weaving Co., Ltd, Jinjiang ("Fulong"), Jinjiang Jianxin Weaving Co., Ltd ("Jianxin") and Jinjiang Fuxin Electroplating Co., Ltd ("Fuxin") (totaling RMB 29.6 million).

The inter-segment sales elimination represented the dyeing and electroplating services provided by the Processing segment to the Zipper segment.

The decrease in revenue from the Zipper segment in 6M2012 was attributable to a deteriorating market for the zipper industry in the PRC which was adversely affected by the general slowdown in the global economy. This had led to the Group reducing its selling prices to retain customers' orders.

The decrease in revenue from the Trading segment was due to a decrease in sales orders during 6M2012.

Gross Profit and Gross Profit Margin

The Group's gross profit decreased by RMB 66.8 million (or 70%) to RMB 28.0 million. The decrease in gross profit was attributable to the reduction in selling prices to retain customers' orders and the increase in the costs of production, mainly increase in direct labour costs and depreciation expense.

Average gross profit margin decreased by 16.5 percentage points to 10.9% due to the decrease in gross profit margin from the Zipper segment in 6M2012. This was attributable to the increase in labour cost and a deteriorating market for the zipper industry in the PRC, which was adversely affected by the general slowdown in the global economy, resulting in the Group reducing its selling prices to retain customers' orders, thus causing erosion in its gross profit margin.

Other income and other expenses

Other income comprises government subsidies, foreign exchange gain and rental income while other expenses consist mainly of agency fee. The net income increase was due mainly to the increase in rental income as well as the foreign exchange gain.

Selling and distribution expenses

Selling and distribution expenses increased by RMB 0.7 million (or 22%) to RMB 3.9 million. The increase was due mainly to an increase in staff costs as basic salaries increased.

General and administrative expenses

General and administrative expenses increased by RMB 12.2 million (or 46%) to RMB 38.7 million. This was attributable to the RMB 4.4 million increase in amortization of intangible assets expense, the RMB 3.6 million increase in allowance for doubtful debts in 6M2012 and the RMB 3.8 million provision of Social Security Insurance computed based on the number of staff in the Group.

The increase in amortization of intangible assets in 6M2012 was due mainly to the increase in intangible assets from the 3 newly acquired subsidiaries in FY2011. The intangible assets mainly consist of customer base and operating license of the 3 subsidiaries namely Fulong, Jianxin and Fuxin acquired by the Group. The amortization periods for the customer base and operating license are 9 years and 21 years respectively.

The significant increase in depreciation RMB 10.5 million was due mainly to an additional properties, plant and equipment acquired in 6M2012 and the consolidation of the 3 new subsidiaries acquired in the second half of FY2011

Finance income and expenses

Finance expenses increased by RMB 0.3 million (or 19%) to RMB 1.7 million. This was attributable to the increase in short-term loans compared to the previous corresponding period. Finance income decreased by RMB 0.1 million (or 12%) to RMB 0.8 million due mainly to a decrease in cash and bank balance.

2Q2012 vs. 2Q2011 (3 months)

Revenue

The Group's revenue decreased by RMB 39.4 million (or 22%) to RMB 138.2 million. The decrease in revenue was due mainly to the decrease in the sales of the Trading segment (RMB 4.6 million), the Zipper Chain (RMB 23.2 million), and the Zipper Slider (RMB 17.4 million). This was partially offset by the increase in revenue contributions from the newly acquired processing operations namely Fulong, Jianxin and Fuxin, totaling RMB 12.0 million.

The inter-segment sales elimination represented the dyeing and electroplating services provided by the Processing segment to the Zipper segment.

The decrease in revenue from the Zipper segment in 2Q2012 was attributable to a deteriorating market for the zipper industry in the PRC which was affected by the general slowdown in the global economy. This had led to the Group reducing its selling prices to attract more orders.

The decrease in revenue from the Trading segment was due to a decrease in sales orders during 2Q2012.

Gross Profit and Gross Profit Margin

The Group's gross profit decreased by RMB 37.9 million (or 74%) to RMB 13.0 million. The decrease in gross profit was attributable to the reduction in selling prices to retain customers' orders and the increase in costs of production, mainly increases in direct labour costs and depreciation expense.

Average gross profit margin decreased by 19.3% points to 9.4% due to the decrease in gross profit margin from the Zipper segment in 2Q2012. This was attributable to the increase in labour cost and a deteriorating market for the zipper industry in the PRC, which was affected by the general slowdown in the global economy, resulting in the Group reducing its gross profit margin to attract more customers' orders.

Other income and other expenses

Other income comprises government subsidies, foreign exchange gain and rental income while other expenses consist mainly of agency fee. The net income increase was due mainly to the increase in rental income and foreign exchange gain.

Selling and distribution expenses

Selling and distribution expenses increased by RMB 0.4 million (or 26%) to RMB 2.2 million due to an increase in staff costs as basic salaries increased.

General and administrative expenses

General and administrative expenses increased by RMB 8.5 million (or 63%) to RMB 22.1 million. This was attributable to the RMB 2.1 million increased in amortization of intangible assets expense, the RMB 2.8 million increased in allowance for doubtful debts and the RMB 3.8 million provision of Social Security Insurance provided for staff in the Group.

The increase in amortization of intangible assets in 2Q2012 was due mainly to the increase in intangible assets from the 3 newly acquired subsidiaries in FY2011. The intangible assets mainly consist of customer base and operating license of the 3 subsidiaries acquired by the Group. The amortization periods for the customer base and operating license are 9 years and 21 years respectively.

The significant increase in depreciation RMB 9.5 million was due mainly to an additional of properties, plant and equipment in 2Q2012 and the consolidation of the 3 new subsidiaries acquired in the second half of FY2011

Finance income and expenses

Finance expenses increased by RMB 0.2 million (or 23%) to RMB 0.9 million. This was attributable to the increase in short-term loans compared to the previous corresponding period. Finance income increased by RMB 0.2 million to RMB 0.7 million due mainly to an increase in interest income from the fixed bank deposits balance.

FINANCIAL POSITION

Non-current assets

As at 30 June 2012, non-current assets amounted to RMB 914.6 million comprising property, plant and equipment, investment property, land use rights, prepayment and intangible assets.

The Group's property, plant and equipment amounted to RMB 358.6 million, an increase of 19% (or RMB 57.4 million) compared to RMB 301.2 million as at 31 December 2011. The increase was due mainly to acquisition of plant and machineries and payment for completion of expansion of zipper production areas in Jinjiang factory.

The significant increase in land use rights and decrease in prepayments were as a result of obtaining the certificate of land use right for the land in Xiamen in 1Q2012.

Current assets

As at 30 June 2012, current assets amounted to RMB 477.4 million, a decrease of 3% (or RMB 14.0 million) compared to RMB 491.4 million as at 31 December 2011. This was due largely to a decrease in fixed deposits, cash and bank balances which were offset by the increases in inventories, prepayments, trade and other receivables.

Inventories increased by RMB 12.3 million due to a buildup of inventory as a result of the decline in sales while production continued on an optimal scale to cover its manufacturing overheads.

Trade and other receivables increased by RMB 18.1 million due to a temporary extension of the credit period with some old customers so as to retain customers' orders.

The increase in prepayments to suppliers was due mainly to the increase in advances made to certain suppliers. The Group made advance payments to these suppliers to secure ready supply of raw materials at competitive prices. It is a usual practice of the Group to make advance payments to suppliers at the beginning of the year to enable the Group to secure the price and supply of raw materials for the whole year. This would enable the Group to enjoy cost savings in the event of raw material price fluctuations.

Fixed deposits, cash and bank balances declined from RMB 255.2 million to RMB 134.6 million due mainly to the payment for completion of production area expansion and advance payment to suppliers.

Current liabilities

As at 30 June 2012, total current liabilities were RMB 232.4 million, an increase of 28% (or RMB 51.0 million) compared to RMB 181.5 million as at 31 December 2011. This was mainly attributable to the increase in trade payables, bills payable to banks, short-term bank loans, amount due to directors, other payables and accruals which was offset by the decrease in income tax payables.

Trade payables and bills payable to banks increased due mainly to the fully utilization of the credit period from suppliers and also introduction of using bills payable in zipper segment so as to maintain the cash on hand.

Other payables and accruals increased due to the increase in advances received from customers. Short-term bank loans increased due as the Group obtained a new short-term bank loans from China CITIC Bank, please refer to page 3 for further information.

The increase in the amount due to a director from RMB5.3 million as at 31 December 2011 to RMB14.9 million as at 30 June 2012 was due mainly to settlement of the cost of acquisition for the land in Xiamen, the salaries due to directors, and professional expenses relating to audit and legal services paid by the Group's Chairman and CEO on behalf of the Company. The reason being the Company's funds were tied in a fixed deposit and were not available until the end of 2Q2012.

In the acquisition of the Land Parcel in Xiamen Island, the local government had requested the Group to settle the cost of acquisition of the Land Parcel within a tight period. In addition, due to the foreign exchange control in the PRC, the procedures and process in application of remittance is complicated and time consuming. The Chairman and CEO, Mr Hong Qing Liang, had therefore remitted the required amount from his personal account in Hong Kong to the Group's subsidiary to settle the cost of acquisition. As agreed with Mr Hong, no interest was charged on the funds contributed by him.

CASH FLOW

Operating activities

Net cash flows used in operating activities in 6M2012 amounted to RMB 41.4 million while cash flows generated from operating activities in 6M2011 amounted to RMB 58.4 million. This was due mainly to the increase in trade and other receivables as a result of the extension of the credit period to customers.

Net cash flows generated from operating activities in 2Q2012 amounted to RMB 23.9 million compared to RMB 42.3 million in 2Q2011. This was due mainly to increase in trade and other receivables as a result of the extension of the credit period to customers

Investing activities

Net cash flows used in investing activities in 6M2012 amounted to RMB 84.2 million compared to RMB 228.5 million in 6M2011, and in 2Q2012 amounted to RMB 58.4 million compared to RMB 227.5 million in 2Q2011, was due primarily to the acquisition of the subsidiaries – Fulong and Jianxin in 2Q2011.

Financing activities

Net cash flows used in financing activities in 6M2012 amounted to RMB 5.3 million compared to RMB 17.9 million in 6M2011, and in 2Q2012 amounted to RMB 4.8 million compared to RMB 17.2 million in 2Q2011, as a result of dividend payment to shareholders in 2Q2011.

For the half year ended 2012, the Group continues to operate under a highly competitive and challenging environment as the zipper industry in the PRC faces intense competition with lower profit margin. Arising from the challenging and competitive business environment, the Group faced a significant reduction in sales arising from shrinkage in demand for zippers as most of the

Group's customers still hold high level of inventories in their warehouse. The average utilization rates of the Group's production facilities in 1H2012 for zipper chains and zipper sliders were approximately 76% and 36% respectively.

Given the slowing down of economic growth in the PRC, uncertainties for export sales, as well as potential cost pressures arising from rising production and labour costs, the Group expects the zipper industry to remain highly challenging and competitive and does not expect the business environment to improve considerably for the rest of 2012.

The Group will strive to enhance its operational efficiency of its plants by implementing higher levels of automation to mitigate the impact of weak demand to the Group's gross profit margins. The Group will also continue to exercise tight control on the administrative expenses and strive to lower the production unit cost and inventory holding cost.
